Executive Council Resolution No. 29 of 2019

**Concerning the fees of Proceedings before the Sharjah International
Commercial Arbitration Centre**

We, Sultan bin Muhammad bin Sultan Al Qasimi, Crown Prince and

Having reviewed:

Law no. (2) of 1999 concerning the establishment of Sharjah Executive
Council, its By-Laws and Amendments,

Law no. (1) of 2003, on regulation of the Sharjah Chamber of Commerce
and Industry (SCCI) and its amendments.

Amiri Decree no. (6) of 2009 on establishing Sharjah International
Commercial Arbitration Centre,

And the Executive Council Resolution No. (17) of 2009 Concerning the
fees of Proceedings before the Sharjah International Commercial
Arbitration Centre,

Based on the review of Chairman of Sharjah Chamber of Commerce and Industry (SCCI) and approval of the Executive Council of Sharjah and the public interest, we have issued the following resolution:

Article (1)

Pursuant to paragraph (9) of Article (6) of the said Amiri Decree no. (6) of 2009, the center charges the following fees:

Article (3)

An intervention request is treated as an arbitration request and all procedures and fees of the arbitration case apply.

Executive Council Resolution no. (17) of 2009 Concerning the fees of Proceedings before the Sharjah International Commercial Arbitration Centre.

Article (5)

This resolution shall come into force as of the date of its publication in the official gazette and competent authorities shall execute this Resolution, each within their own jurisdiction.
